

# Hot Sugar Band's Agreement :

## **The parties agree as follow :**

**1. Location of performance :** *(Specify the physical location of Concert).*

**2. Date(s) and time(s) of performance :**

The employer engages under his civil and financial responsibility the artist, against which this one agrees to provide the performance in accordance with the terms of the Agreement and any attached addenda or riders.

**3. Performance fees :**

The employer shall pay artist a total compensation of \_\_\_\_\_ **Euros including tax**, on invoice.

A deposit of 30% will be paid at the signature of this agreement. The remainder of the payment must be made in cash, by check or by bank transfer before the concert or within a maximum of 30 days after the concert.

#### **4. Conditions of performance :**

**(a) Travel :** All travel expenses must be paid entirely by the employer. This includes :

- \* Plane tickets (SkyTeam companies by preference) or train tickets.
- \* Travel to and from the residence, when travelling to and from the airport (Subway, bus, car and car park). **Payment by cash against receipts.**

A person from the organization will be in charge to pick up the group "Hot Sugar Band" by car at the airport at the time of his arrival and bring them back on the day of departure.

#### **(b) Accommodations :**

The members of the Hot Sugar Band would prefer to have 1 room each (7 in total) in a hotel. In case of impossibility, 4 double rooms, but with 2 separate beds.

The hotel should be as close as possible to the place of performance (less than 500 meters). Otherwise, a person will be in charge to pick up the members of the group at the hotel and drive them to the place of performance and drive them back to the hotel whenever necessary (for sound check, before and after the concert).

#### **(c) Food and drinks :**

Meals will be at the employer's expenses for lunch and dinner (hot meals, balanced and served at table) during the journey and during all the staying. A per diem (lump sum) may be discussed and, if necessary, established in advance. No allergies for anyone.

Drinks (softs and alcohol) will be included on the days of performance.

#### **5. Cancellation policy :**

In the case of cancellation by the employer or arising out of his liability, he shall pay the artist an indemnity under the financial conditions (3) :

1. All deposit fees are non-refundable.
2. The employer must pay **60%** of the fees to the artist if he cancels between 2 months and 1 month before the performance date and **100%** if he cancels less than 1 month before that date.

**Both parties accept the terms of this contract, under the responsibility of the contractors who signed after reading.**
